Thank you for your cooperation to safeguard our health and campus during the fifth wave of this Covid-19 epidemic. Given the latest situation, the following updated campus entry measures will be implemented with immediate effect:

Daily Rapid Antigen Test (RAT)

In response to the announced government arrangement for "daily RAT" in the school sector, we encourage you to conduct RAT before you come back to campus. If you encounter financial difficulties in doing so, please contact FEO for support as necessary.

Latest Covid-19 Vaccine Record Registration

If you have not yet reported to us your <u>latest</u> Covid-19 Vaccine Record, i.e. your <u>2nd</u> <u>or 3rd dose</u> of vaccine, you are reminded to do so well before your next entry to the campus, to avoid congestion at the main campus entrance. COVID-19 Vaccination For Persons with Prior COVID-19 Infection

In general, if you have <u>recovered</u> from COVID-19 infection (and have documented proof of recovery as described below), you can take <u>one less dose</u> of vaccine than the general <u>requirement in the above table</u>. Please remember to inform the Institute / College by <u>completing the electronic form (URL) given below for your prior COVID-19 infection and recovery</u> for updating your vaccination record in our entry checking system.

Please pay attention that if you acquired COVID-19 infection and was tested <u>positive</u> for the first time <u>within 14 days after</u> receiving <u>vaccination</u>, you <u>should not take one less dose</u> of COVID-19 vaccine despite this infection episode.

Reporting System for Positive COVID-19 & Recovery of Students from COVID-19

Requirement on Reporting System for Confirmed/Preliminary Positive COVID-19 cases and Recovery of Students from COVID-19 will remain the same.

Students must inform the Institute / College by completing the following electronic form (URL) if they have (1) received COVID-19 nucleic acid testing (核酸檢測) AND are found to be either a Confirmed case (確診), or a Preliminary Positive case (初步確診); or (2) obtained a positive result after Rapid Antigen Test (快速抗原檢測後呈陽性結果). Documentary proof of Recovery

For students who have recovered, you are required to present the relevant proof of recovery or infection, such as:

- Hospital discharge letter or
- SMS/electronic/paper record of nucleic acid test negative result issued by the Government or private laboratories which are recognised under the Laboratory Recognition Scheme of the Department of Health (DH) or
- SMS/electronic record of completed declaration on DH's "Declaration System for individuals tested positive for COVID-19 using Rapid Antigen Test" or
- Isolation order issued by the DH, or
- Any other recovery records issued by the Government or the Hospital Authority.
