Subject: Reporting System for Recovery of Students from COVID-19

Dear Students,

We hope this email finds you safe and well.

As mentioned in the previous COVID-19 circular (nCoV-103 Updated Learning & Teaching Arrangements for Semester 2 of the 2021-22 Academic Year), if you are tested positive using either Covid-19 Rapid Antigen Test (RAT) or nucleic acid test, you are required to submit proof of a negative test result before re-entry onto campus premises. Pursuant to the latest government policy on the anti-epidemic measures, with immediate effect from 9 March 2022, you are now allowed to submit either your negative test result obtained from a nucleic acid test or from a RAT.

Recovery cases who have received at least two doses of COVID-19 vaccines

If you have received at least two doses of COVID-19 vaccines, you may **conduct RATs on Day 6* and Day 7* or any 2 consecutive days after Day 7*** of the mandatory quarantine period. If the RATs on these two successive days were negative, please retain and **upload your RAT negative result photos of the above-mentioned days to the link of our institute below** to update us on your recovery. This process is important for us to maintain up-to-date information for the relevant parties' reference; your negative results must also be reported via the system below before your re-entry to campus.

Recovery cases who have not been vaccinated or have only received one dose of COVID-19 vaccine

If you have not been vaccinated or have only received one dose of COVID-19 vaccine, you are required to undergo 14 days quarantine and medical surveillance. You have to **conduct RAT** on the Day 14* of your quarantine period and upload your RAT negative result photo of the above-mentioned day to the link below to update us on your recovery. This process is important for us to maintain up-to-date information for the relevant parties' reference; your negative results must also be reported via the system below before your re-entry to campus.

Alternatively, if you are required to undergo compulsory COVID-19 nucleic acid test at Community Testing Centre (CTC) on Day 12*, please retain and upload the SMS notification containing the result of the Day 12* test at CTC to the link below.
