2. All students are required to attend registration according to schedule.

If you do not complete your student registration on schedule, you will not be permitted to attend classes or continue with your study programme. It is essential that you read all the notices you received about student registration, follow the instructions and adhere to the deadlines.

3. All new students are required to join the SAO briefing sessions. Information of application to MTR Student Travel Scheme, Financial Assistance, NMTSS, Student Survey and Compulsory Cartias Character Building Programme would be included.
